

## Contract Agreement

THIS AGREEMENT made this \_\_\_\_\_ day of **OCT 14 2019** 2019 between HOME GUARANTY CORPORATION (HGC) now **PHILIPPINE GUARANTEE CORPORATION**, represented herein by its Acting Executive Vice President, **JIMMY B. SARONA** of Makati City, Philippines (hereinafter called "the Entity") of the one part and **TRI-AXIS SURVEYING AND ENGINEERING SERVICES** represented herein by its Owner/Sole Proprietor, **ALIVER E. MANGONON** of Baguio City, Philippines (hereinafter called "the Supplier") of the other part:

**WHEREAS**, the Entity invited Bids goods and ancillary services, viz., for the provisions of services of an External Licensed Geodetic Engineer to conduct and complete the three (3) phases of survey works on Phase 2 of Pinesville Subd. In Brgy. Kias, Baguio City and has accepted a bid from the Supplier for the supply of those goods and services in the sum of **One Million Three Hundred Thirty-Five Thousand Four Hundred Four and 80/100 Pesos (Php 1,335,404.80)**. (herein after called "the Contract Price").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (*e.g.* bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract;
  - (f) the Performance Security; and
  - (g) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.




